

BEAUTY FEVER

INTERNATIONAL BEAUTY COMPETITION.

PARTICIPANTS' REQUIREMENTS:

age 16-30 years. No height restrictions.

Nationality and language: any. Country of origin: any. Female from birth.

PRIZE FOR THE OVERALL WINNER:

First prize worth 1000 euros for a photo shooting + first classified band and crown.

Official face of the competition with its own image throughout the One-year communication: posters, postcards, Interviews on radio, newspapers and TV.

OTHER PRIZES: They will be offered to all miss (including the same first-place miss) other Job opportunity awards in various entertainment sectors (dance, singing, acting, commercials, catchall) offered by the competition partnerships.

ART 1 premise: local selections take place through licensees provincial and/or regional of any country.

ART 2 Final event: organizing the world finals for the election of MISS BEAUTY FEVER.

The competition can therefore provide a launch opportunity for talented candidates in the fields of advertising, fashion, cinema, television and entertainment.

ART 3 All the selected candidates will participate in the final through the regional finals or direct convocation of the contest's patron and producer Lele Dinero who is qualified.

The Miss minors can participate in the contest only if accompanied by at least one of the parents who will have to sign with you the following rules.

ART 4: The jury will vote for all those present with a voting system from 1 to 5 for face, physique, posture and talent.

ART 5: The candidate who wins a band during a regional final has the right and also the obligation to attend the world final of this year. Non-participation without a just cause (indicated only in the health reasons with supporting documentation, thus excluding any other motivation related to study or work or other reasons not related to health impediments) is to be considered serious damage against the organization that can claim compensation for damages which is fixed in euro 1000 as of now.

ART 6: It is the option of Patron Lele Dinero to suspend, cancel, revoke the prize and the right to participate of a Miss in the competition if one or more conditions of the rules are violated, or if the candidate has committed immoral or otherwise objectionable behavior.

ART 7: Various.

The behavior of the candidates should be marked by the absolute fairness and morality both in private and public towards colleagues as well as the journalists, the jury and the organizers. The organization of the contest will not be liable to the candidates in any way in case of cancellation and/ or postponement of the Contest at any stage.

Participation in the contest implies full and complete acceptance of these rules and the decisions made by the organization may not be challenged by the candidates or their family members otherwise penalty for damages.

Each candidate to the contest agrees to sign an accident insurance and regardless of this with the signing of the release the talent scout and the management are exempt from any civil and criminal liability, resulting from any damage to itself or to third parties.

MANDATORY NOTES: During the world final, participants will be entitled to:

Certificate of participation. Presence in the recorded TV clips. 1 consumption + water and a hearty quality dinner buffet.

The Miss Final participants are responsible for: the journey to the venue and the return trip. Stay accommodation in a partner hotel or elsewhere.

INTEGRATIONS: The decisions of the jury or the Patron are final and the participants declare that they accept this condition without any reservation.

By signing this regulation, it is understood that the waiver is also signed, whereby the contestants agree to grant the organization the right to use their image in relation to photos and recordings that will be made during the event dates.

Criticism, reservations, or statements from participants or third parties that, in the opinion of the Patron, may even minimally damage the image of the competition will be pursued legally both under criminal and civil law.

The candidate indemnifies the organization from any civil or criminal liability arising from any damage caused to themselves personally or by things or people, whether for their own damages or towards things and/or persons (in this regard, it is at the discretion of each candidate to take out insurance for any damages and/or injuries at their own expense).
